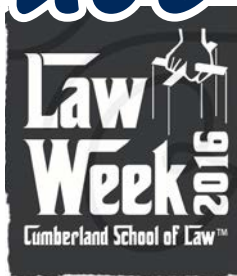
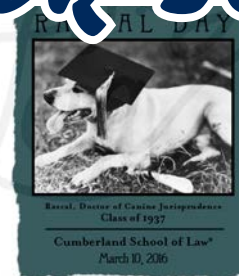
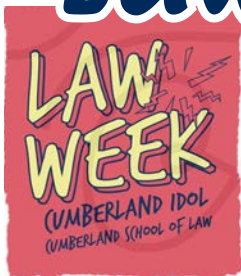

Rascal Awarded Doctor of Canine Jurisprudence in 1937



On Thur. March 10 at 11 a.m., the Law School will honor the memory of Rascal, the only recipient of the Doctor of Canine Jurisprudence degree, at the annual Rascal Memorial Procession. Students, faculty, and friends of the Law School (along with their pets) will proceed behind a New Orleans-style jazz band from the foot of Samford's Centennial Walk to the Angel Patio on the east side of Robinson Hall.

After a moving eulogy delivered by Professor Howard Walthall, mourners and pets will enjoy a hotdog lunch served by Cumberland faculty. As always, judges will be awarding prizes in several categories, including the Best Dressed Dog, the Best Trick, the Dog Most Resembling Its Owner, the Smallest and Largest Dog, and the Dog That Most Represents the Spirit of Rascal.

According to Cumberland tradition, Rascal was a mongrel pup who faithfully attended classes at the law school's former home in Lebanon, Tennessee, beginning in 1933, and in 1937 he was presented the rare degree of Doctor of Canine Jurisprudence. Rascal passed away in 1940 and was buried with much ceremony beneath the window where he attended classes. When Cumberland moved to Birmingham in 1961, Rascal's tombstone and a few spadefuls of dirt were brought to the Samford Campus, and again interred at Blackacre, on the west side of Robinson Hall.

Make sure you and your pet come out for a great afternoon of live music, free food and prizes in this fun-filled tradition honoring Rascal, Cumberland's own CJD.

TO RUN FOR AN OPEN POSITION:

All candidates running for one of the SBA or Honor Court positions must:

1. Complete the letter of intent for the position of which you are running. You **MUST** submit a [Letter of Intent](#) to be placed on the ballot.

2. Submit the completed letter of intent **NO LATER** than **Thur., March 10 at 4 p.m.** Any form submitted after this deadline will not be considered.

3. Attend a **MANDATORY** candidates meeting on **Sun., March 13 at 5 p.m.** in The Great Room. Any candidate who fails to attend the meeting will not be eligible to run.

Campaigning will begin on **Mon., March 14 at 12:01 a.m.** and will end **Thur., March 31 at midnight.**

Candidates who attempt to campaign outside of those time limits will have their names removed from the ballot.

Elections will take place from **9 a.m. to 4 p.m.** on **Thur., March 31.**

The link to submit your letter of intent also contains links to the Cumberland Honor Code and Elections Code. Candidates must remain in compliance with both codes in order to run for office.

Williams Trial Competition Finals Held on Wednesday

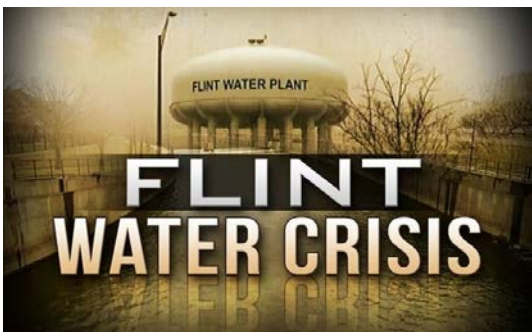


(from left to right) Drew Bentley, Katie Hilyer, Amy Chiou, Krista Tribble will compete in the Final Round of the Williams Trial Competition.

Judge Abraham Caruthers Fellows Applications Still Accepted

Applications to be a Judge Abraham Caruthers Fellow for the 2016-17 academic year are now being accepted from rising second and third year law students. The deadline for applications is **Friday, March 11, 2016**. Successful applicants must be second or third year law students at Cumberland School of Law who have either a 3.0 cumulative grade point average or are in the top 35 % of their class. It is also desirable that the applicants have knowledge of and experience with information technology systems as they relate to training in legal writing and legal skills. In addition to possessing excellent legal reasoning and writing skills, the successful applicants must possess outstanding interpersonal skills as this position involves working closely with the law school students, faculty and administration.

Interested students should submit a hard copy of your resume and a short application letter to Prof. Stoddard. The letter of application should include a statement of the reasons for the applicant's interest in participating as a Caruthers Fellow.

Faculty Notes



Professor Wendy Greene was interviewed on the current status of Title VII protection against misperception discrimination in the workplace. On March 2, quotes from the interview were featured in the BNA Daily Labor Report article: [“Is Perceived-As Bias Prohibited by Title VII?”](#). Professor Greene’s award-winning article, “Categorically Black, White, or Wrong: ‘Misperception Discrimination’ and the State of Title VII Protection” is an influential authority on the issue, and her findings were also cited in the BNA analysis. On March 18, Greene will present her scholarship on misperception discrimination as a special plenary panelist during the 14th Annual Marco Biagi Foundation (MBF) Conference. The MBF Conference is an international meeting devoted to international and comparative employment and labor relations hosted by the University of Modena in Modena, Italy; this year, 13 countries will be represented.



On Fri. March 4, the Center on Law and Information Policy at Fordham University Law School hosted a workshop in New York City for **Professor Woodrow Hartzog’s** ‘02 forthcoming book, “Privacy’s Blueprint: The Battle to Control the Design of New Technologies.” Experts in law and technology from around the US came to give feedback on the work in progress.
