Law Week Celebrations Continue After Weather Delay



Due to winter weather, some of last week's Law Week events, including Rascal Day were rescheduled for this week. On Monday March 9, the annual Rascal Day celebrations were held. Rascal Day honors the memory of Rascal, the only recipient of the Doctor of Canine Jurisprudence degree. The annual event encourages students, faculty, staff, and friends of the law school to bring their dogs to campus for a parade and lunch. Dogs may also sit in on classes throughout the day.

During the Memorial Procession, approximately 50 dogs and their owners marched behind a saxophonist from the foot of Samford's Centennial Walk to Robinson Hall. University President Dr. Andrew Westmoreland, his wife Dr. Jeanna Westmoreland and their two Corgis lead the parade. Professor Belle Stoddard, dressed as Cruella De Vil, threw stuffed Dalmatians to bystanders during the parade. 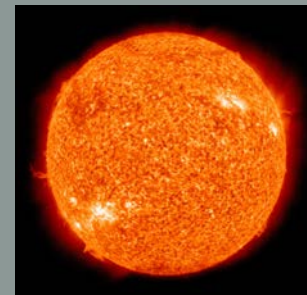
