Exam Information

Complete exam information, including exam schedules, policies and procedures, and exam software information, is located online. All students are encouraged to carefully read this information prior to the beginning of exams. Following are a few highlights:

- Alternates Students must gain permission from the professor no later than 4:30 p.m. on the last day of classes (April 28) if they plan to take an exam at an alternate time. The professor (not the student) is responsible for the submission of an alternate exam envelope to Mrs. Zimmer. A list of all alternate exam envelope submissions will be posted on the law school website and the bulletin board outside the Associate Dean's office on April 29, the day after classes end. Students should check the posting and contact their professor if their name does not appear on the list.
- Arrival Students should carefully check the exam schedule to ensure that they know the date and time of exams. Students should arrive early enough (15-20 minutes before start time) to get settled and make sure their computer works, Extegrity loads, etc.
- Technology Students using technology should make sure their computers are in good working order well in advance of exams. Students will need to download the new version of the Exam4 software. PREVIOUS VERSIONS HAVE EXPIRED, including the midterm version. Complete download instructions are on our website. Student should complete several practice tests (choosing the "S15 Practice Exam" option from the course dropdown box), submit the practice tests wirelessly, and notify Jeff Whitcomb prior to the beginning of the exam period with any technology problems.

✓ Composites

The composite for the Class of 2015 has arrived and is hanging in the Riley Road foyer. Graduates may stop by Student Services to receive a free 11" x 14" copy of the large composite.



Members of The American Journal of Trial Advocacy celebrate the end of the academic year at their banquet on April 23.



Two French journalists, Vincent Alexander Jean-Claude Jarnigon, Editor-in-Chief, Ouest-France, Rennes (Daily) and Violette Lazard, Investigative Reporter, Le Nouvel Observateur (Weekly), visited Cumberland School of Law on April 23 as part of the International Visitor Leadership Program, sponsored by the U.S. Department of State Bureau of Educational and Cultural Affairs' International Visitor Leadership Program and facilitated by Global Ties Alabama (formally the International Services Council of Alabama). The journalists met with Cassandra

Adams, Director of the Cumberland Community Mediation Center and Public Interest Program and the immediate past chair of the board of directors for Alabama Appleseed Center for Law and Justice (AACLJ), as well as Noah Jones, Policy Advocate for the AACLJ. The group discussed initiating systemic policy reform to achieve justice for marginalized citizens. The journalists spent three days meeting with journalists, lawyers, judges, government officials and community leaders in Huntsville and Birmingham before returning to France.
