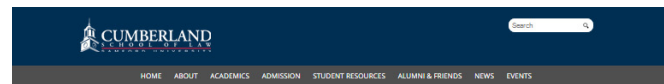

## New Website for the Law School

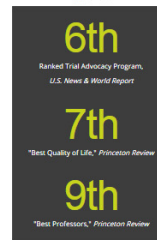
Cumberland School of Law launched a **new website** earlier this week—be sure to check it out!

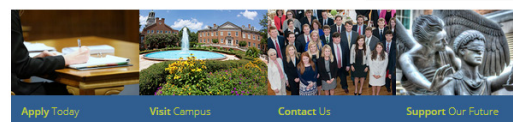

## Faculty Notes

**Associate Dean Brannon Denning's** article "Wynne: Lose or Draw?"

with Norman R.

Williams contributes to a roundtable that considers *Maryland State Comptroller of the Treasury v. Wynne*, to be argued before the Supreme Court on Nov. 12, 2014. In *Wynne*, the Court considers whether the Constitution bans a state from taxing its residents' income, wherever earned, by requiring a credit for taxes paid on income taxed in other states. The Court could answer many questions: How far is the reach of the dormant Commerce Clause in the context of income taxation? What is the extent of a state's power to enforce personal income taxes on its residents? What kinds of residents are subject to double taxation and why? Professors Edward Zelinsky, Dan Coenen, Brannon Denning, Norman Williams, Michael Greve, and Adam Thimmesch tackle these questions and more in their contributions.



**Professor Robert "Bob" Goodwin** recently published two books. One book was the fourth edition of his casebook, *Criminal and Forensic Evidence: Cases, Materials, Problems* (4th ed. LexisNexis). For the second book, Prof. Goodwin joined Charles Gamble and Terry McCarthy on the third and latest edition of *Gamble's Alabama Rules of Evidence: A Trial Manual For Making and Answering Objections*.



**Terry McCarthy** serves as an adjunct professor at Cumberland School of Law. He has taught Evidence, and is currently teaching the the Advanced Evidence course. This semester, McCarthy is using the *Gamble's* book in his Advanced Evidence class.

## Nominate a Professor for the Harvey S. Jackson Excellence in Teaching Award

Cumberland has a long history of outstanding teaching, and superior teaching is a critical part of the school. In order to foster and recognize outstanding teaching at Cumberland, two alumni provided a generous gift to endow the **Harvey S. Jackson Excellence in Teaching Award**. Two Jackson Teaching Awards are given each year--one to a professor who teaches first year courses and one to a professor who teaches upper level courses.

Students are encouraged to nominate professors for these awards. Any Cumberland student or faculty member may nominate a professor for the award by sending an email to Dean Henry Strickland which explains how the nominee meets the criteria for the award. The criteria are:

1. Mastery of the subject matter;
2. Ability to convey information effectively to students
3. Demonstrated enthusiasm for teaching;
4. Commitment to excellence in the classroom;
5. Innovation in teaching techniques;
6. Commitment to students

You may nominate someone whose course you are currently taking, someone whose course you have taken in the past, or someone with whom you have had other contact that demonstrates outstanding teaching in relation to the criteria above.

A joint committee of faculty and students will choose the winners, and we will announce the winners in the spring. A faculty member who has won the award in a particular category is not eligible to receive that award again for a period of three years. The faculty members who currently are ineligible to receive the award in a category because they have received it in the past three years are Professors Evans and Hartzog (First Year Courses) and Professors Ross, Johnson, DiRusso and Walthall (Upper Level Courses). The names of all of the award winners are on a plaque outside the Great Room.

Please take time to nominate a professor for this important award. In your nomination, please specify which award you are nominating a professor for – the First Year Award or the Upper Level Award and briefly explain why you think the nominee is deserving.
