### Trial Team Places in Top Eight in Mock Trial Challenge

This past weekend, national trial team members Drew Panella, Curtis Seal, and Bianca Svensson competed at the South Texas College of Law's Fifth Annual Mock Trial Challenge. One of the few teams composed of only second year law students, the team litigated their way to the quarter-final round before being eliminated. Their efforts placed them in the top eight teams out of more than thirty law schools from across the country.

Panella, Seal, and Svensson competed against students from the University of the Pacific, St. Mary's School of Law, The University of Houston, The University of Pennsylvania, and Stetson School of Law. Bianca Svensson was recognized as an outstanding advocate. The team was coached by Bains Fleming '07 and Setara Foster '12.

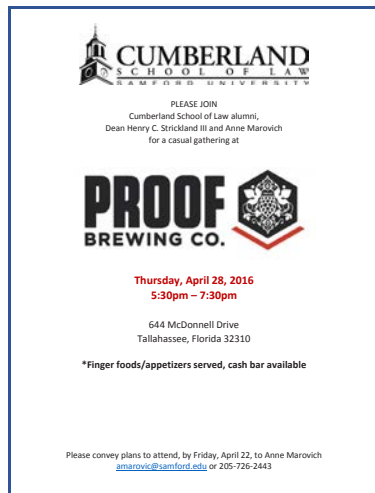

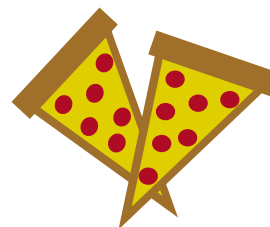

# End of Semester Updates

## Evaluations:

- (1) SBA started visiting classes last week to encourage participation and answer questions.
- (2) You should have received an email with a link to the evaluation of each course in which you are enrolled. Please take a few minutes to complete these for each of your courses/professors.
- (3) Classes with at least a 75% participation rate by noon Tues., April 19 are invited to attend a pizza party on Thur., April 21 at 11 a.m. in the Great Room.



## Alternates:

- (1) You must gain permission from your professor no later than 4:30 p.m. on the last day of classes (April 26) if you plan to take an exam at an alternate time.
- (2) Your professor is responsible for the submission of an alternate exam envelope to Mrs. Zimmer; students may not turn in their names or an alternate exam envelope to Mrs. Zimmer. This process is handled administratively by the professor or his/her assistant.
- (3) A list of all alternate exam envelope submissions will be posted on the bulletin board outside the Associate Dean's office on April 27, the day after classes end. You need to check the list for your name and information. If you receive permission from your professor for an alternate but your name does not appear on the list, you need to contact your professor.

## Computer Software:



- (1) You will need to download the new version of the Exam4 software at <http://exam4.com/>. ALL PREVIOUS VERSIONS HAVE EXPIRED, including the midterm version. Complete download instructions are on our website at [http://cumberland.samford.edu/files/Extegrity\\_Instructions.pdf](http://cumberland.samford.edu/files/Extegrity_Instructions.pdf)
- (2) The new computer exam software is available for download now through May 2. In previous semesters, the download option has remained available throughout the examination period. This year, the downloads will be **unavailable after May 2**.
- (3) Complete several practice tests (choosing the "S16 Practice Exam" option from the course dropdown box). You may take as many practice exams as you wish, but always choose the practice exam course selection when taking a practice exam.
- (4) Submit the practice tests wirelessly.
- (5) Notify [Ms. Nelson](#) prior to the beginning of the exam period if you notice any problems with your technology. Technology assistance will be more limited once exams begin.
