## Faculty Notes



In May, **Professor Wendy Greene** traveled to Havana, Cuba with a delegation of over 100 lawyers, judges, and law professors as a part of the National Bar Association's (NBA) International Affiliates Meeting. During this historic visit, Professor Greene delivered a CLE presentation on her scholarship on misperception discrimination and examined race, color, and gender dynamics in the Americas and Caribbean with Cuban officials. In her capacity as Special Advisor on Cuba, Professor Greene also secured a private briefing at the U.S. Embassy and assisted with the

planning and execution of the Continuing Legal Education program consisting of six panels in Havana.

In July, upon the invitation of the immediate past president of the National Bar Association, civil rights attorney Benjamin Crump, **Professor Greene** served on the Presidential Showcase opening the NBA's 91st annual convention in St. Louis, Missouri. She lectured on parallel forms of race, color, and gender discrimination affecting African descendants in the United States and Brazil. During the annual meeting, Professor Greene also spoke on a panel sponsored by the NBA's Young Lawyers Division exploring non-traditional careers for lawyers.

**Professor Greene** was also selected to participate in the Institute for Constitutional History's summer research seminar, "The Reconstruction Amendments: Freedom, Equality, and the American Constitution, at Stanford Law School. In July, she attended this week-long, interdisciplinary workshop for university instructors who currently teach or plan to teach courses on constitutional law and history.
