Applications are now being accepted and are due on Wednesday, April 19, 2017.



The American Inns of Court organization began in the 1980s and is I now considered the nation's premier organization for promoting ethics and professionalism. The American Inns of Court are modeled on the English Inns of Court where senior lawyers and judges act as teachers and mentors to newer lawyers and law students. We, at Cumberland, are fortunate to have an Inn of Court chartered here at the law school. It is named after Judge James Edwin Horton, a Cumberland graduate who is a wonderful example of judicial courage. Rising third year Cumberland students have the opportunity to be members of our Inn of Court. The Inn generally meets on the third Tuesday of the month at 5:30 PM. The meetings last until 7:00 PM and feature outstanding programs on ethics, professionalism and what it means to be a lawyer. In the first semester we meet in September, October and November and in the spring semester, we meet in January, February, March and have a social gathering in April. The meetings have food and appropriate beverages. Lawyers and judges pay dues to be members but there is no charge to law students. If you join, you will:

- Become a member of a pupillage group of lawyers, judges and law students who meet informally and who also plan programs
- Have the opportunity to be mentored by a senior lawyer or judge
- Receive great programming on ethics and professionalism issues
- Have the opportunity to network with some of the finest lawyers and judges in our area.

- Whelan W. and Rosalie T. Palmer Professor of Law **Alyssa DiRusso** has been awarded status as a Certified Financial Planner by the Certified Financial Planner Board of Standards, Inc. CFP® status requires compliance with standards of education, ethics, experience, and an examination.
- On Friday, April 21st, **Professor Wendy Greene** (visiting at the University of Kentucky College of Law) will be participating in the convening of contributors for CRITICAL RACE JUDGMENTS: REWRITTEN U.S. COURT OPINIONS ON RACE AND LAW, a forthcoming book under contract with Cambridge University Press. The convening will be held at Brooklyn and Fordham University Law Schools. At Fordham, she will deliver her invited contribution: a revised opinion of Saint Francis College v. Al Khazraji, 481 U.S. 604 (1987).

On May 10th, Professor Greene will be serving as an invited panelist for a program devoted to "The Legacy of





Justice Thurgood Marshall" during the Federal Judicial Center's Workshop for Judges of the Sixth Circuit Court of Appeals in Cleveland, Ohio. During the fall of 2017, Professor Greene will also serve as a visiting professor at the University of Iowa College of Law. At Iowa, she will teach Employment Law and Critical Race Theory.
