#### **Cumberland School of Law National**

**Trial Team** — Stephanie Gushlaw ('19), Jennifer Jayjohn ('19), Craig Shirley ('19), Andrew York ('19), and Denzell Moton ('19) won first place this past weekend in the National Civil Trial Competition Championship hosted by Loyola Los Angeles School of Law. The team defeated Stetson University College of Law, Baylor University School of Law, Temple University Beasley School of Law, and Chicago Kent School of Law. This victory over four teams that are ranked by U.S. News and World Report in "The top ten law schools for Trial Advocacy," is even more impressive because all the team

members are 2L students who have never participated in a national competition before. Andrew York won Best Advocate in the final round. The team was coached by Judge Jim Roberts ('94) and Sara Williams ('06).

#### **Cumberland School of Law National** Trial Team Members — Keith Stephens ('18),

Candace Towns ('18), Kameron Buckner ('19), and J.B. Brown ('19) - competed October 20-22, 2017, in Pontiac, Michigan, at the National Trial Advocacy Competition hosted by the Young Lawyers Section of the State Bar of Michigan. Including a bye round, the team went undefeated in the tournament, taking first place honors with a 5:0 record. Stephens and Towns advocated for the defendant, and Buckner and Brown advocated for the plaintiff in a civil racial profiling case. The Cumberland students defeated teams from Duquesne University School of Law, University of Illinois, Wayne State

University, and The John Marshall Law School. Candace Towns received an individual award for Best Direct Examination after her brilliant witness presentation in the round against Duquesne. Setara Foster ('12) and Matt **Woodham** ('15) coached the team. "I could not be more proud of these students. It is incredible what they have accomplished, especially with three of our advocates never having been to a competition before," said Woodham. Foster agreed and added, "These amazing young men and women have grown tremendously as advocates. I could not be more proud of Keith, Candace, Kameron, and J.B. They embody everything great about Cumberland Law!"

#### **Lone Star Classic National Trial Team**

➤ A team of second-year and third-year law students competed this past weekend in the Lone Star Classic Trial Competition hosted by St. Mary's University School of Law in San Antonio, Texas. The team— Callie Brister, Ashley Feltman, Morgan Hoggle and Kingsley Okpara — faced SUNY Buffalo Law School, University of South Carolina School of Law, and the University of Maryland Francis King Carey School of Law, who eventually went on to win the tournament. Cumberland's Kingsley Okpara won the award for Best Opening Statement out of the sixteen teams and sixty-four advocates competing in the event. This team was coached by Spenser Templeton '15 and Stewart Alvis '17.

#### A monument

to honor **Judge James E. Horton Jr.**(Cumberland class of 1899) was dedicated in front of the Limestone County Courthouse, Athens, AL, on October 13th.

In 1933, Judge Horton set aside the verdict and death sentence of an all-white jury that found an African American young man guilty of rape.



Knowing his unpopular decision would end his career, he stood by the rule of law and upheld the dignity and integrity of the court. Judge Horton's judicial philosophy may be summed up in a phrase he learned on his mother's knee: "Let Justice Be Done Though the Heavens May Fall."


The Symposium will be kicked off by Dr. Stuart Hoffman, Scientific
