



Faculty Notes

- On March 1, **Judge John L. Carroll** was elected as chair of the Alabama Fair Ballot Commission. The Fair Ballot Commission is a state commission responsible for drafting plain language ballot statements to explain to voters the meaning and consequences of constitutional amendments which appear on ballots during state elections.
- On March 9 and 10, **Judge Carrol**l will be in Chicago at a meeting of a drafting committee of the Uniform Law Commission. The committee is drafting legislation to harmonize the law of Canada and the United States as it relates to the enforcement of foreign money judgments.
