


Samford University recorded its eighth consecutive record enrollment in fall 2016 with 5,471 students. The total exceeded the previous year's record of 5,206.

Included in the totals are 3,341 undergraduate and 2,130 graduate/professional students—both records—representing 47 states and 29 other countries. About two-thirds of the students are from outside Alabama.

Also included was a record 916 first-year full-time students, exceeding the previous record of 826 set in 2015.

Faith Development Enriches Learning Experience

Faith development is an integral part of the Samford University experience. As one of the top private universities in the United States, Samford remains firmly rooted in its Christ-centered mission. Throughout the year, students have opportunities to engage their faith and service in the classroom and in the community.

Home Groups

Twenty-eight home groups hosted by employees and area alumni involved 328 undergraduate and graduate students. Each home group has a facilitator and a cofacilitator for a total of 56 student leaders who help run the program.

Campus Worship

A variety of worship opportunities on campus, including services coordinated by the Office of Spiritual Life and Beeson Divinity School, attract hundreds of students each week.

Faith Enrichment Lecture Series

Twenty-four campus lectures, coordinated by the Office of Spiritual Life, reached cumulative attendance of 1,800 students. The lecture series connects Christian faith and learning across an array of academic disciplines.

Care Team

This team provides support to students in varying degree of crisis, including the deaths of students' family members or loved ones.

Spiritual Life Assistants

Residence hall chaplains stationed across campus provide pastoral care and spiritual support to residential students.

Global Missions Scholars

This program provides scholarship money, training, vocational counseling and mentorship in preparation for careers in long-term international missions.





Community Engagement:

A Hallmark of the Samford Experience

Samford University actively promotes the civic engagement of students locally and globally. Community service and classroom learning both encourage students to focus their gifts on a world in need. At Samford, this includes a wide range of curricular and cocurricular opportunities.

In 2016, more than 800 students participated in the annual Samford Gives Back Day at 38 service sites. Organized by a student-led leadership team, the event provides an entry point for Samford students and student organizations to cultivate relationships with Birmingham community agencies.

Partners Acting in the Community Today (PACT) is a new student-led organization that empowers Samford students to build relationships with partner agencies. PACT is led by student liaisons who facilitate service initiatives on and off campus with Samford's PACT community partners.

Students served weekly for a combined total of more than 1,250 hours at six community sites in cadres led by PACT liaisons with partners such as East Lake United Methodist Church, Habitat for Humanity, The Exceptional Foundation and Restoration Academy.

Some examples of the many other community engagement initiatives during 2015-16:

- Kinesiology students in the School of Health Professions went on the sixth annual medical mission trip to the Dominican Republic.
- Students in the new Doctor of Physical Therapy program went on a medical mission trip to the Dominican Republic.
- Students in a Brock School of Business economics and poverty course helped Birmingham's Christian Service Mission build a house in an impoverished area of the city.
- Students volunteered during spring break at Give Kids the World, a storybook resort that provides cost-free vacations to children with life-threatening diseases.
- Interior architecture students integrated faith, talent and scholarship to design a medical clinic in India through Design Education for World Impact.
- First-year law school students donated 430 hours of service to several Birmingham area agencies as part of orientation through the Cumberland Public Interest Project.



Samford Opens New College of Health Sciences Facilities

In August 2016, Samford University opened its new College of Health Sciences facilities, an innovative learning environment designed to foster interprofessional collaboration and cutting-edge experiential learning. The nationally recognized faculty are preparing students to meet the growing demand for skilled and compassionate health care providers.

The College of Health Sciences is home to the School of Health Professions, Ida Moffett School of Nursing, McWhorter School of Pharmacy and the School of Public Health. The college is now the largest academic unit at Samford, and also houses the collaborative Center for Faith and Health. Located in the former Southern Progress Corporation headquarters purchased by the university in late 2014, the facilities span 223,000 square feet. On average, approximately 1,200 students utilize the facilities daily.

A 22,000-square-foot simulation center provides discipline-specific and interdisciplinary learning opportunities that improve technical skills, clinical judgment, decision making, communication and teamwork. The new College of Health Sciences has been described as one of the largest and most innovative health care education centers in the country. These facilities provide room for growth in new programs that are under consideration for expansion in the years ahead.



Achievements Bring National and International Recognition for Samford

Samford University students, faculty and alumni earned national and international recognition for significant achievements highlighting scholarship, research and performance. Some of the many highlights include the following:

- Sam Hahn, a May 2016 graduate and University Fellows honors student, was named a **Rhodes Scholar finalist** and was one of 10 students in the nation accepted to the ninth cohort of the **Lilly Graduate Fellows Program.**
- Heather A. West, assistant professor, world languages and cultures, was named a Chevalier de l'Ordre des Palmes
 Académiques (Knight of the Order of Academic Palms) by the government of France. The honor recognizes those
 who have rendered eminent service to French education and have contributed actively to the prestige of French
 culture.
- Political science major and University Fellows honor student Fernanda Herrera took part in the Congressional
 Hispanic Caucus Institute, the nation's premier Hispanic youth leadership development and educational
 organization.
- Samford's **Ethics Bowl** team captured first place in the Southeastern Intercollegiate Ethics Bowl championship and qualified for the national championship competition.
- Samford Opera won second place in the National Opera Association's collegiate scene competition for the second straight year.
- A unique conference, funded by the John Templeton Foundation and the Issachar Fund, anchored a season of
 thought-provoking events hosted by Samford University's Center for Science and Religion. "Transhumanism and the
 Church: Theological Reflections on Technology and Human Enhancement" assembled a diverse group of scholars to
 consider the ways the church might respond to technologies that could revolutionize our bodies and minds.
- Carol Ratcliffe, associate professor, nursing, received the Nurse Educator of the Year Award from the National Black Nurses Association.

- The A Cappella Choir won the **Grand Prix** at the international choir festival Siauliai Cantat in Lithuania in May, also capturing the Prize of the Audience along with first-place awards in every category they entered: Youth Choirs, Music after 1950, Spirituals and Folk.
- McWhorter School of Pharmacy student Caitlyn Cleghorn, and Howard College of Arts and Sciences alumni Frances
 Isbell '15, David Osula '15 and Rachel Stokes '14 are among 16 graduate students in Alabama named to the inaugural
 class of Alabama Albert Schweitzer Fellows. They are spending a year learning the social factors that impact health
 and developing lifelong leadership skills through service projects that address the root causes of health disparities in
 under-resourced communities.
- Natalie Bennie and Marley Davis were named **Debate All-Americans**, a designation reserved for the nation's top 30 debaters.
- Marshall Cates, professor, pharmacy practice, was selected for the American Association of Colleges of Pharmacy
 Innovations in Teaching Award.
- Jeff Cole, a spring 2016 graduate, received a National Science Foundation Graduate Research Fellowship.
- **Demondrae Thurman,** professor, music, spent the summer touring with the New York Philharmonic, playing euphonium and bass trumpet for concerts in New York City; Shanghai, China; and Vail, Colorado.
- Ida Moffett School of Nursing launched a program designed specifically to meet the needs of **veterans seeking** a **Bachelor of Science in Nursing.** Funded by a \$1,047,385 grant from the U.S. Department of Health and Human Services' Health Resources and Services Administration, Samford is introducing an innovative program that prepares veterans to pursue careers as registered nurses.
- A Samford team finished in third place nationally in the Public Relations Student Society of America's 2016
 Bateman Case Study Competition.
- Erin Mauldin, assistant professor, history, received Georgetown University's 2016 Harold N. Glassman Award for
 a Dissertation in the Humanities. The award is the university's highest accolade to its recent doctoral alumni for
 scholarly accomplishment.

Samford Athletics Celebrates Year of Championships, Honors

- Samford's athletics teams are ranked first in the Southern Conference and in Alabama for Graduation Success Rate by the NCAA, with an average score of 98 percent. Ten teams posted perfect scores.
- Samford teams claimed four Southern Conference championships during the 2015–16 season: women's indoor track and field; softball (regular season and tournament); and soccer (regular season). Samford has won 30 championships since joining the conference in 2008.
- Samford placed 194 student-athletes on the Southern Conference Academic Honor Roll during the 2015-16 academic year.
- Senior soccer player Jermain Seoposenwe represented her native South Africa in the 2016 Olympic Games.
- Pole vaulter Tray Oates placed fourth at the U.S. Olympic Trials. He was Samford track and field's first male All-American first-team selection after finishing seventh overall at the NCAA Outdoor Track and Field Championships.
- Men's and women's tennis earned All-Academic Team status from the Intercollegiate Tennis Association.
- Samford hosted both the Southern Conference and NCAA Indoor Track and Field Championships at the Birmingham Crossplex.

Samford Celebrates 175 Years

Few institutions reach the milestone that Samford University celebrates in a yearlong 175th anniversary celebration.

In the autumn of 1841, an idea was rooted in the hearts of four courageous Baptists in central Alabama: a vision of the importance of establishing and endowing a college of high character. In uncertain economic times, with no faculty, no library and no facilities, Howard College received its charter from the state of Alabama on December 29.

Samuel Sterling Sherman, the university's first president and its only faculty member, welcomed the first students to the fledgling college on January 3, 1842.

The college was born in difficult days and has endured many trials: devastating fires, ravages of war, bankruptcy, three locations and many economic challenges, including the Great Depression. The institution easily could have failed had it not been for the support of loyal friends, alumni, students and employees.

The vision of the founders extended into the mid-20th century when the college's leaders realized the need to set a new course. Relocation to the current campus and expansion of academic programs resulted in unprecedented growth. In 1965, the institution became the university we know today: Samford, one of the nation's top Christian universities whose influence spans the globe.

Even as the first 175 years are celebrated, the vision of the founders is providing the foundation for a vision of the future—one of academic excellence, leadership, service and compassion, firmly rooted in the university's Christian mission.

Updated Campus Master Plan Sets Course for Samford's Future

Samford University's 175-year history is one of academic excellence and leadership. The vision of the institution's founders to provide a college of high character is as strong today as it was in the beginning. That vision is taking new root in the first major update of the university master plan since the campus moved to its current location in the 1950s.

The university engaged Birmingham-based Davis Architects and Boston-based Dober Lidskey Mathey to assist with developing the new plan.

The plan features four primary phases that align with the university's strategic plan, and addresses needs in a long-term, fiscally appropriate and responsible way. The plan provides for a superior teaching and learning environment, and allows for growth of new and existing academic programs.

The plan provides support for continued growth at Samford. Samford's enrollment has grown 22 percent over the last 10 years.

The multiyear plan includes four phases:

Phase one

includes new residence facilities to accommodate expected growth and renovations to existing academic spaces for Howard College of Arts and Sciences and the School of the Arts. The centralized relocation of admission and other student services also is included.

Phase two

includes renovations to the university center, the university library and other academic space, as well as additional parking.

Phase three

includes additional residential space and parking to accommodate expected growth.


Phase four and independent projects

include additional housing and parking, and renovations to athletics facilities and the fine arts center.

The master plan also includes a comprehensive program to address infrastructure needs for the entire campus, increase energy efficiency, practice campus-wide conservation, and refresh and renew every facility. Samford has retained Johnson Controls Inc., a global leader in the manufacture and promotion of energy efficiency technologies, to oversee implementation of the infrastructure plan.

The infrastructure improvement program represents a \$31 million effort to implement improvements across campus over the next 24 months. The plan includes indoor and outdoor lighting upgrades across the campus, domestic water conservation, window replacements in numerous buildings, piping insulation, improvements in buildings' automation systems, heating/venting/air conditioning upgrades, a new campus chilled water plant, electrical and mechanical improvements, and other projects.

The expense of the projects will be repaid through the energy savings achieved over the JCI contract term, and the resulting improvements are expected to generate more than \$1.65 million in savings annually. In the process, the university will provide a cleaner, safer environment, reduce energy expenses and accomplish considerable improvements to many facilities. The net impact of the changes should be a reduction of more than 15,000 metric tons of carbon dioxide each year and an annual savings of more than 20 million gallons of water.

Building a strong future for Samford University

Forever Samford is a six-year, \$300 million capital campaign that was launched publicly in fall 2016. It is the largest undertaking of its kind in Samford University's 175-year history. It will help to ensure that Samford continues to prepare and send dedicated, thoughtful, ethical people throughout the world.

The campaign goals are in four major areas:

Scholarships

\$90 million

Although we strive to keep tuition affordable, the total cost of a four-year undergraduate degree from Samford now approaches \$160,000. Generous scholarships enable us to open our doors to student leaders whose talents and achievements will have a wide influence.

Academic Programs \$90 million

Endowed professorships and ample research funds enable us to better support the outstanding faculty we have, and to attract talented new scholars and teachers. We also can continue to grow the depth and breadth of our rigorous academic programs.

Places and Spaces

\$60 million

While our campus is beautiful and functional, many of our spaces are in their seventh decade, and in need of upgrading and renovation. We are building innovative new spaces to house relevant academic programs. We also are creating new gathering spaces where both campus and community can come together to share ideas and inspiration.

A Solid Foundation \$60 million

It costs \$165 million per year to operate a quality university such as Samford. Only 70 percent of this cost is covered by tuition and fees. We can close this gap and sustain the momentum and progress that has made Samford a top nationally ranked university.
