- Describe the concept of a racialized imagination and some implications for the practice of health care.
- Identify key values from social ethics that can inform the work of health care professionals to address questions of social questions of social injustice that impact health and well-being.
- Discuss how the COVID-19 pandemic has affected the clinical use of psychotropic medications.
- Describe the complexities of psychotropic medication use in people who are infected with COVID-19.
- Recognize the psychotropic medications that have potential therapeutic effects against COVID-19.
- Identify the impact of the COVID-19 pandemic on social work practice on service delivery and education.
- Recognize how lessons learned from COVID-19 have influenced the social work profession and highlighted the multi-faceted concept of self-care.
